Let it be known to whom it may concern that the following changes have been made to the call for Senior or Junior Visiting Professors Abroad, in the year of 2019. Such changes reflect the changes that have been made by Capes in the selection of applicants, in the *Sistema de Controle de Bolsas e Auxílios – SCBA*, under the Institutional Program of Internationalization (PII), as follows.

Call 01/2019 - Amendment 01 Senior or Junior Visiting Professors Abroad

1. Let it be known, to whom it may concern, that the Call for Senior or Junior Visiting Professor Abroad, in the year of 2019, within the scope of the Institutional Project of Internationalization (*PII*) under the Capes-PrInt Program, in the year 2019, is now open, as follows.

2. Purpose

- 2.1 This call aims to award postdoctoral research grants to PUCRS faculty teaching in the Graduate Programs participating in the *PII*.
- 2.2 This call for proposals will award projects in 2 (two) financial aid categories: (1) Grants associated with Cooperation Projects and (2) Grants not Associated with Cooperation Projects Office of the Vice President.
 - 2.2.1. The source of financial aid must be indicated by the applicant in the application form.
 - 2.2.2 For grants to be awarded under the category Grants not Associated with Cooperation Projects Office of the Vice President, preference will be given to the countries listed as priorities by CAPES, as per <u>Appendix 1 of Call 41/2017 of the Institutional Program of Internationalization CAPES-PrInt.</u>
- 2.3 This call for proposals includes the following categories:
 - 2.3.1 Senior Visiting Professor Abroad: Professors working at PUCRS, holding a PhD for more than ten (10) years, counting from the last date of registration in the program. The Senior category is intended to award faculty with certified leadership skills in the academia or who have done research that has produced recognized scientific and technological findings in their area;
 - 2.3.2. Junior Visiting Professor Abroad: Professors working at PUCRS, holding a PhD for up to ten (10) years, counting from the last date of registration in the program. The Junior category is intended to provide opportunities for further study and research for professors with an eye to the consolidation of their academic career.

- 2.4. These are the goals of this Call under the PII:
 - 2.4.1. To promote the mobility of professors from PUCRS to Higher Education Institutions abroad;
 - 2.4.2. To consolidate and promote international partnerships;
 - 2.4.3. To advance the development of international research networks with an eye to improving the quality of the scientific and technological production associated with the Graduate Programs.

3. Duration and number of grants

- 3.1. The amount of the award to be given to applicants selected for the Senior Visiting Professor Abroad or Junior Visiting Professor Abroad is presented in Appendix I of this document.
- 3.2. The grant will be awarded from a minimum of (3) months and a maximum of twelve (12) months. This period cannot be renewed, as stated in Call No. 41/2017 of the Institutional Program of Internationalization Capes /PrInt.
- 3.3. Once the university grants the applicant a leave of absence, the grant will be awarded for the period of time requested by him / her in order to conduct his / her studies at the host institution.
- 3.4 Applications presenting different dates for the start and end of studies as well as inconsistent schedules of activities, negative responses from the institutions involved or any other documents, will be rejected.

4. Eligibility Criteria

- 4.1 The applicant must fulfill the following requirements at the time of registration:
 - 4.1.1. To be an active full-time professor at PUCRS, teaching in an accredited Graduate Program in that institution. This program must have been selected for the PII;
 - 4.1.2. Have relevant scientific and technological production (publications in journals, books, events or national and / or international patents qualified in the Area of expertise of the faculty);

- 4.1.3. To have demonstrated ability to train human resources (Undergraduate, Scientific Initiation, Master's, Doctorate and postdoctoral advising), as well as the capacity to attract resources through research projects;
- 4.1.4. The application must be in an area compatible with the professor's expertise and be in line with the Institutional Plan of Internationalization of the University and with the PII;
- 4.1.5. Not to have been awarded with this type of grant in the last 24 (twenty-four) months.

5. Documentation

- 5.1. Registration form completed and signed, as per Appendix II of this document.
- 5.2. A list of the applicant's 5 (five) most relevant publications, including a justification for each publication.
- 5.3. Letter of Acceptance from the Institution that will host the faculty, stating the leave of absence.
- 5.4. Research Project, with a maximum length of 15 (fifteen) pages, to be carried out during the period abroad, including the following:
 - 5.4.1. Introduction, including context, problem to be addressed and proposal;
 - 5.4.2. Relevance, including the state of the art;
 - 5.4.3. General and specific objectives;
 - 5.4.4. Methodology;
 - 5.4.5. Schedule of activities, which must be compatible with the duration of the faculty's stay abroad:
 - 5.4.6. A detailed schedule of advising and co-advising activities to be assumed by another faculty while the selected applicant is working on their research abroad;
 - 5.4.7. Contribution of the project to the promotion of education, training and teaching, whenever applicable;
 - 5.4.8. Potential to increase and / or consolidate the research network, including new techniques and partnerships, as well as dissemination of results, whenever applicable;
 - 5.4.9. Relevance for the scientific and technological development of the area at PUCRS in the medium and long run;
 - 5.4.10. Expected Results, including impacts on the Graduate Program the applicant is embraced by, publication of co-authored articles, student mobility, among others;
 - 5.4.11. References.

- 5.5. Letter from the Coordinator of the Graduate Program (s), the applicant is embraced by, including a brief description of the expected impact on the scope of operation of the Program (scientific and technological production, projects in international networks, CAPES evaluation).
- 5.6. Summary of the curriculum vitae of a faculty member from the host institution, including brief description of the quality of the institution of destination.
- 5.7. Letter from the applicant stating that he / she is proficient in the language of the destination country and / or in English.
- 5.8. The registration documents must be sent in .pdf format to the email address <u>diretoriapg.print@pucrs.br</u>, as stated in Section 5 of this Call:
 - 5.8.1. The type of grant, the funding category, and the name of the Cooperation project, if applicable, must be included in the subject of the email;
 - 5.8.2 Applications submitted after deadline stated in Section 7 of this document will not be accepted.

6. Requesting a Leave of Absence

- 6.1 Applicants selected to conduct "Post-doctoral Internships" as Senior or Junior Visiting Professors Abroad must request a Leave of Absence to the Office of Graduate Programs of the Office of the Vice President for Research and Graduate Programs as per the PROPESO Procedures Manual.
- 6.2 The selection for the grant does not construe automatic granting of the Leave of Absence for faculty participating in the grant Senior or Junior Visiting Professors Abroad.

7. Schedule

7.1. The schedule for the program is as follows:

8. Selection

- 8.1. The type of funding to be awarded will be taken into consideration for the selection of proposals:
 - 8. 1.1. Grants Associated with Cooperation Projects: The Office of Graduate Studies will look at the documentation submitted by the applicant, and will issue a decision regarding the applicant's application. The Selection Committee will comprise 3 (three) members: the Coordinator of the Cooperation Project and 2 (two) other

persons. One member assigned by the Coordinator of the Cooperation Project and another will be assigned by the Manager. The decision must be agreed by at least two members of the PII's Management Group. The Selection Committee will be responsible for analyzing the merits, judging and classification of proposals.

- 8 .1.2. Grants not Associated with Projects Office of the Vice President: The Office of Graduate Studies will look at the documentation submitted by the applicant, and will issue a decision regarding the applicant's candidacy. The Selection Committee will comprise of 3 (three) members to be appointed by the Manager. This decision must be agreed by at least two members of the PII's Management Group, including 1 member of PROPESQ. The Selection Committee will be responsible for analyzing the merits, judging and classification of proposals.
- 8.2. The following aspects will be taken into consideration for the selection of proposals:
 - 8.2.1. Analysis of Documents: Applicant's Curriculum Vitae, Host Professor's Curriculum Vitae and quality of the Host Institution.
 - 8.2.2. Merit of the Research Project: Project must be in line with the Priority Area and Cooperation Project, whenever applicable; Consistency and relevance of goals; Execution plan must be clear and detailed; Impact on the Graduate Program (s), as well as within the scope of the PII; Feasibility and quality of the project to be developed (methodological aspects and schedule of activities); and Relevance and possibility to produce findings.
- 8.3 The Analysis of Documents and the Merit of the Research Project will be taken into consideration. Since the areas are different, the weights assigned to the Document Analysis and Merit of the Research program must be fair.
- 8.4. If the number of candidates is lower than the number of grants, the tiebreaking criteria may not apply.
 - 8.4.1. Tie-breaking criteria:

9. Results

- 9.1. Results will be disclosed as follows:
 - 9.1.1. Grants Associated with Cooperation Projects: The result of the selection process will also be announced http://www.pucrs.br/print/calls-for-applications/;
 - 9.1.2. Grants not Associated with Projects Office of the Vice President: The result of the selection process will also be announced http://www.pucrs.br/print/calls-for-applications/.

10. The Appeals

- 10.1 Applicants may appeal the final decision, by sending an email to diretoriapg.print@pucrs.br within 7 days, after the date the results were published on http://www.pucrs.br/print/calls-for-applications/.
- 10.2. The appeal will be analyzed by, at least, 3 members of the PII's Manager Group.
- 11. Nominations and Implementation of the grant:
 - 11.1 Once all requirements have been met, applicants will be selected.
 - 11.2 The implementation of the grant will fall to Capes.

12. Benefits

- 12.1. The benefits to be awarded in the category Senior Visiting Professor Abroad and Junior Visiting Professor Abroad, as stated in <u>Call 41/017 Capes-PrInt Items to be awarded funding abroad Appendix 10</u>.
- 12.2. The grant and its corresponding benefits are to be granted according to Appendix I of this document.
- 12.3. Benefits are not extended to dependents.

13. Final Considerations

13.1. It is the responsibility of the applicant to obtain the appropriate visa at the consulate of the country in which he / she intends to develop their postdoctoral research, if necessary.

It is recommended to apply for the visa in advance since visa processing time may be varied.

- 13.2 Applicants awarded with this grant will be required to, upon their return to Brazil, when requested, hold seminars, write papers and / or join events to exchange practices.
- 13.3 Applicants awarded with this grant must send an end-of-activity report (no specific template) to the following email address: directoriapg.print@pucrs.br, within a maximum period of 3 (three) months starting from their return to Brazil.
- 13.4 The applicants awarded with this grant must mention that the award was granted by Capes, as per Call 41/2017 of the Institutional Program of Internationalization CAPES-PrInt, whenever findings are disclosed.
- 13.5 As stated in the CAPES Call 041/2017, at least 70% (seventy percent) of the resources will be allocated to partnerships with universities from countries with which Capes cooperates effectively.
- 13.6 The country of destination should be included in the list of destinations eligible for the priority area (Health in Human Development: World in Motion: Individuals and Society or Technology and Biodiversity: Sustainability, Energy and Environment) with which the Cooperation Project is associated.
- 13.7 This Call has been designed in accordance with Article 3, Clause 3.4, item 3.4.1.9 of CAPES Call 041/2017 Institutional Program of Internationalization CAPES-PrInt.
- 13.8 No grants will be awarded to relatives or spouses up to third degree, as per Decree 7203 dated Jun 4, 2010, as stated in STF Binding Abridgement No. 13.
