- 1. Let it be known, to whom it may concern, that the Call for Visiting Professor in Brazil, within the scope of the Institutional Internationalization Project (*PII*) under the Capes-PrInt Program, in the year 2019, is now open as follows.
- 2. Purpose
 - 2.1 This Call for Proposals, within the PII, aims to increase the actual number of international faculty, to teach courses and deliver on-site training programs, presentations or seminars.
 - 2.2 This call for proposals will award projects in 2 (two) financial aid categories: (1) Scholarships associated with the cooperation project and (2) Scholarships associated with the Office of the Vice President.
 - 2.2.1 The source of financial aid must be indicated by the applicant in the application form.
 - 2.2.2 For grants to be awarded under the category 'Scholarships not Associated with Cooperation Projects Office of the Vice President', preference will be given to the countries listed as priorities by CAPES, as per <u>Appendix 1 of Call 41/2017 of the Institutional Program of Internationalization CAPES-PrInt.</u>
 - 2.3 To follow are the goals that are intended to be achieved by this call for proposals within the PII:
 - 2.3.1 To increase the international collaboration network of PUCRS' Graduate Programs;
 - 2.3.2 To consolidate and to promote international partnerships;
 - 2.3.3 To encourage the development of international research networks aimed at improving the academic production quality of Graduate Programs.



- 3. Duration and Number of Scholarships
 - 3.1 The total number of grants for Visiting Professor in Brazil is presented in Appendix I.
- 4. Eligibility Criteria
 - 4.1 The applicant must fulfill the following requirements at the time of registration:
 - 4.1.1 Have a PhD and relevant academic production, especially within the last 5 (five) years;
 - 4.1.2 Have a relevant academic production, preferably within the last 5 years;
 - 4.1.3 Be employed by an institution from outside of Brazil. Applications from scholars who are teaching or doing research in Brazil will not be accepted.
 - 4.2 It is desirable that the applicant be paired up with a local faculty at the host institution for assistance during their stay in Brazil and at PUCRS.
- 5. Documentation
 - 5.1 Registration form completed and signed, as per Appendix II of this document.
 - 5.2 Copy of the doctoral degree diploma.
 - 5.3 Copy of the passport.
 - 5.4 Work Plan, in Portuguese or English, addressing the following criteria:
 - 5.4.1 Title, applicant name and area of expertise;
 - 5.4.2 Activity program including, for instance, short-term courses or training programs. The proposed programs must include purposes and goals to be developed during the scholar's stay at PUCRS and make use of the university's infrastructure. It must state that it will be of benefit to the largest number of members of the academic community, especially students;
 - 5.4.3 Schedule of execution of the activities to be developed by the applicant, with the expected date of development of each activity;
 - 5.4.4 Relevance of the theme;
 - 5.4.5 Theoretical and methodological basis for the development of the work plan;
 - 5.4.6 Anticipated impacts during the stay, within the goals of PII;
 - 5.4.7 References.
 - 5.5 Curriculum Vitae.



- 5.6 Letter from the applicant, in English or in Portuguese, certifying their compliance with the terms and conditions for the program to be developed during the specified period of their stay. This letter must include the date and a signature.
- 5.7 Letter from the applicant's home institution certifying their compliance with the applicant's length of stay at PUCRS.
- 5.8 The documentation for this call must be submitted in PDF file, as stated in section 5 of this Call, to <u>diretoriapg.print@pucrs.br</u>.
 - 5.8.1 The type of grant, the funding category, and the title of the Cooperation Project, if applicable, must be included in the subject of the email.
- 6. Additional Documents
 - 6.1 For the implementation of the grant, CAPES will request the signature of a Grant Agreement.

7. Schedule

8. Selection

- 8.1. The type of funding to be awarded will be taken into consideration for the selection of proposals:
 - 8.1.1 Scholarships associated with the cooperation project: The Office of Graduate Studies will look at the documentation submitted by the applicant, and will issue a decision regarding the applicant's application. The Selection Committee will comprise 3 (three) members: The Coordinator of the Cooperation Project and 2 (two) other persons one (1) member assigned by the Coordinator of the Cooperation Project and 2 (two) another assigned by the Coordinator of the Cooperation Project and 2 (two) members. The Selection Committee will be responsible for analyzing the relevance, qualification and classification of proposals.
 - 8.1.2 Scholarships associated with the Office of the Vice President: The Office of Graduate Studies will look at the documentation submitted by the applicant, and will issue a decision regarding the applicant's candidacy. The Selection



Committee will comprise of 3 (three) members nominated by the manager of the IIP Manager as per the 2 IIP Manager Group members, including one PROPESQ member. The Selection Committee will be responsible for analyzing the relevance, qualification and classification of proposals.

- 8.2. The scientific merit will be evaluated according to the following criteria:
 - 8.2.1 Quality, regularity and relevance of applicant's scientific production with the Work Plan and/or Cooperation Project, if applicable, within the scope of PII;
 - 8.2.2 Applicant's expertise in the proposed project academic area;
 - 8.2.3 Availability to advise graduate students, if applicable;
 - 8.2.4 Viability of the work plan, in view of the infrastructure available in the graduate program and the duration of the requested scholarship;
 - 8.2.5 Expected results and impacts under the PII;
 - 8.2.6 Relevance of the proposed work plan considering its internationalization impact in the Graduate Program and PUCRS;
 - 8.2.7 Coherence and relevance of the applicant's qualifications in view of the objectives, activities and goals proposed.
- 9. Result
 - 9.1 Results will be disclosed as follows:
 - 9.1.1 Grants associated with Cooperation Projects: Results of the selection process will also be announced on <u>http://www.pucrs.br/print/calls-for-applications/;</u>
 - 9.1.2 Grants not Associated with Cooperation Projects Office of the Vice President: Scholarships Associated with Cooperation Project: Results of the selection process will also be announced on http://www.pucrs.br/print/calls-for-applications/.

10. The Appeals

- 10.1 Applicants may appeal the final decision, by sending an email to <u>diretoriapg.print@pucrs.br</u> within 7 days, after the date the results were published on <u>www.pucrs.br/print</u>.
- 10.2 The appeal will be analyzed by the IIP Manager Group at PUCRS.

11. The Benefits

- 11.1 Financial aid and corresponding benefits will be awarded according to Call 41/2017 Capes-PrInt – Financed Items of Scholarship in Brazil – Appendix 11.
- 11.2 Benefits are not extended to dependents.



- 11.3 Applicants are not entitled to any other benefits other than those described herein.
- 11.4 The Medical, Dental and Pharmaceutical assistance of internationals in Brazil will be carried out by the Unified Health System (SUS), as per the agreement signed between the Ministries of Foreign Affairs (MRE) and the Ministries of Health, on January 25, 1994.
- 11.5 Capes will not reimburse airfare purchased outside the program's rules and will not grant tickets to spouses of dependents.

12. Obligations

- 12.1 Below are the Visiting Scholar's obligations:
 - 12.1.1 The visiting Scholar will be responsible for obtaining the appropriate visa to come to Brazil. The type of visa will depend on the activities to be developed. The visa must be valid for the period of the applicant's stay in Brazil.
 - 12.1.2 Ensure and monitor the planning, organization and execution of the activities stated in the Work Plan, both the individual and collective ones;
 - 12.1.3 To be fully committed to the academic and research activities at graduate level programs at PUCRS;
 - 12.1.4 Send, at the beginning of the visit, the Agreement including a date and signature, and the exact length of stay in Brazil, as approved by CAPES;
 - 12.1.5 Send airline tickets up to 05 days after arrival in Brazil and upon return to the country of origin;
 - 12.1.6 Applicants will be required to prepare a report of the activities developed, within the scope of the Capes-PrInt program, during their stay in the Institution, containing a copy of the generated products, such as defense papers, seminars delivered and other documents that could attests the productivity and impact.
 - 12.1.7 Applicants will not be entitled to receiving financial aid from other Brazilian agencies or entities cumulatively.
- 12.2 Below are the host professor's responsibilities:
 - 12.2.1 To orient and assist the visiting professor in whatever issues they might encounter in Brazil, including visa application, purchasing of air tickets, application for the National Registration of Foreigners - RNE (in the Federal Police Department) and apply for the Internal Revenue Service of brazil), opening of a bank account, housing and health services issues;

13. Final Considerations

- 13.1. Below are the host professor's responsibilities:
 - 13.1.1. Work closely with the scholar, comply with program's guidelines and standards, and report on any problems or irregularities, as they will act as



an interlocutor between the Office of Graduate Studies / Propesq and the grantee.

- 13.1.2. Ensure and monitor the planning, organization and execution of the activities stated in the Work Plan, both the individual and collective ones;
- 13.1.3. Work closely with the scholar, comply with program's guidelines and standards, and report on any problems or irregularities, as they will act as an interlocutor between CAPES and the visiting professor.
- 13.1.4. In case the scholarship is interrupted, inform the Office of Graduate Studies / Propesq as soon as possible and send a justification for the cancellation;
- 13.1.5. To assist the international scholar in obtaining the CPF number, opening of a bank account, finding housing and available health services.
- 13.2. Scholarship recipients may be required to hold seminars, write papers and / or hold events to exchange practices.
- 13.3. Recipients of the award must send an end-of-activity report to <u>diretoriapg.print@pucrs.br</u> not more than three (3) months after they return to Brazil.
- 13.4. As referred in this Call for Proposals shall refer to the financing granted by CAPES, within the scope of the Call No. 41/2017 Program for Institutional Internationalization CAPES-PrInt, whenever disclosure of the results obtained.
- 13.5. As stated in Call No. 41/2017 of the Program for Institutional Internationalization CAPES-PrInt, at least 70% (seventy percent) of the resources will be allocated to partnerships with institutions from countries with which CAPES cooperates effectively.
- 13.6. The applicant's home country should be included in the list of destinations eligible for the priority areas (Health in Human Development, World in Motion: Individuals and Society, or Technology and Biodiversity: Sustainability, Energy and Environment) by which the Cooperation Project is embraced.
- 13.7. This Call for Proposals has been designed in accordance with Article 3, Clause 3.4, item 3.4.1.9 of the CAPES Notice 041/2017 Program for Institutional Internationalization (CAPES-PrInt).
- 13.8. No awards will be granted to relatives or spouses up to third degree, according to Decree 7203 of June 4, 2010 in Binding Summary No. 13 / STF (Federal Supreme Court).
